<u>Resolution March-2024/14/79</u>: - The Academic Council unanimously resolved that the recommendation proposed by the BOS to be APPROVED (the minutes of meeting of BOS held on 07<sup>th</sup> March 2024) as circulated.

<u>Item No. March-2024/14/80:-</u>To ratify the proposal for an additional division of M.Sc(Computer science) with 30 seats and Establishment of two new programs BSc. (Data Science) and M.Sc(Computer Application) from the academic year 2024-2025.

The Member Secretary apprised the council of the decision made by the College management to pursue the application for an additional division in M.Sc. Computer Science and to propose the inception of the aforementioned new programs. It was highlighted that the eligibility criteria for both the new programs align with the standards set by the parent university, and no alterations have been made in this regard.

<u>Resolution March-2024/14/80:-</u> The council, having duly considered the proposal and hereby resolves to:

- 1) Ratify the establishment of an additional division in M.Sc. Computer Science, accommodating 30 seats, effective from the academic year 2024-2025.
- 2) Approve the establishment of the new programs B.Sc. in Data Science, with an intake capacity of 80 seats, M.Sc. in Computer Application, with an intake capacity of 30 seats commencing from the academic year 2024-2025.

<u>Item No. March-2024/14/81:-</u> To approve and accord sanction Sem I(as per NEP) syllabus with evaluation pattern and marking schema for B.Sc.(Data Science) and M.Sc.(Computer Application) as recommended and approved by various Board of Studies.

Inputs in the form of suggestions and recommendations in the new syllabi for Sem I(as per NEP) from the Board of Studies have been duly considered and accordingly changes/ modifications have been made in the syllabi, also got the confirmation and approval for the updated syllabus from all the BOS members through mail.

**Discussion :-** Dr. Supriya Patil raised a query regarding the IKS course offered in the first semester of the B.Sc (Data Science) program. Dr. Patil suggested that, according to the new guidline regarding IKS, the course should be generic in nature. It was agreed upon that the IKS course content should align with the circular's guidelines to ensure its generic nature.

Professor Avinash Khumbhar and Dr. Supriya Patil have proposed a revision of the course code for the M.Sc. in Computer Applications program. They argue that with the implementation of ABC accounts, it is imperative for the course codes to be unique and distinguishable from those of other programs. This suggestion has garnered unanimous agreement among all council members. Dr. Janardan Pawar assured the council members that the college will diligently review the course codes and make necessary revisions as deemed appropriate.
