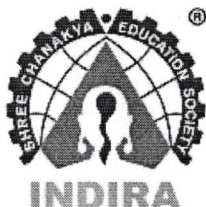

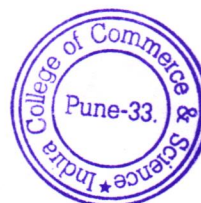

## **Vision of the institution**

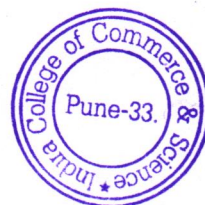

2. The institution is also given a mandate for holistic development of the learners and to meet expectations of the society and to pursue all the expectations of its stakeholders.

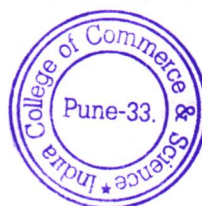
## **Credo of the institution**

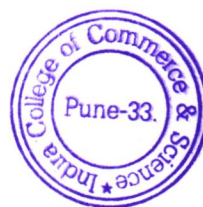


#### 4. Infrastructure:

- College encompasses well- furnished, well ventilated, spacious sufficient number (23 classrooms) which are ICT enabled where the provision of Multimedia learning, smart board, Wi-Fi connectivity and internet access is given for conducting theory classes. Institution has well designed and well maintained auditorium.
- ICCS has 5 Computer laboratories and 1 Electronic Laboratory which are well equipped with state-of-the-art equipment and facilities.
- All the laboratories are established as per UGC norms, equipped with 230 properly maintained computer system, these labs are utilized for conducting practical classes as per the requirements of the curriculum. Labs have sufficient licensed software and open-source tools to cater the requirements of curriculum & industry enabled teaching.
- The entire campus is Wi-Fi enabled with 24/7 internet facilities to the students and staff. including labs, classrooms, library and offices of all Departments.
- Sports room of college provides facilities for various indoor games like Chess, Table Tennis and Yoga which builds the students physically mentally rich.

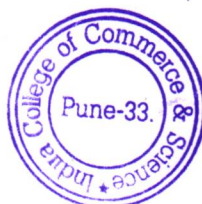

1. The institution has constituted all the obligatory bodies such as IQAC, Governing Body, Academic Council, Finance Committee, Examination Committee, Board of Studies of all the programs and other committees as per norms laid down by the U.G.C. for autonomous colleges.
2. The functioning and conduct of the academic activities are in tune with Academic Calendar of the college.
3. Proceedings and functioning of all the mandatory bodies is compliant with the guidelines and documentation for the same has been maintained.
4. It is observed that the I.Q.A.C. of the college is playing an active role in maintaining quality standards in Teaching- Learning process and functional enough to conduct various curricular, co-curricular and extracurricular activities in college.
5. It is observed that the college has been maintaining high academic standards in curriculum design, teaching, assessment strategies and research.
6. College encompasses a well maintained lush green campus ensuring adequate availability and optimal utilization of physical infrastructure for teaching learning activities.
7. College maintains transparency in all activities by involvement of stakeholders like students, teachers, Alumni and Employers etc. And take regular feedback from all the stakeholders to improve the quality of education.

The External Committee has made the following recommendations for the enhancement of college performance:

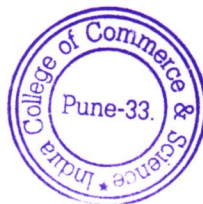
1. College should encourage student entrepreneurs to boost Incubation and Startup culture.
