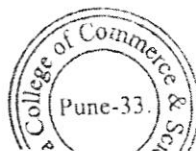

The college has scrutinized various aspects like infrastructure availability and due to the overwhelming response received by the college for the MSc (Computer Science) Program, we are proposing the establishment of an additional division for MSc (Computer Science) with a capacity of 30 students and asked for suggestions and recommendations regarding the notion from all the Governing Body members.

Prof. Shivendu Bhushan sir discussed the inputs in the form of suggestions and recommendations about the additional intake of 30 seats from the Board of Studies - Comp. Sci and IT have been duly considered and we also got the confirmation and approval for the same from all the BOS and Academic Council members through the mail.

The Members of the Governing body unanimously approved the additional M.Sc. (Computer Science) division with 30 students, from the academic year 2024-2025.
