The External committee has made the following observations after its interaction and review of the documents:

- The institution has constituted all the obligatory bodies such as IQAC, Governing Body, Academic Council, Finance Committee, Examination Committee, Board of Studies of all the programs and other committees as per norms laid down by the U.G.C. for autonomous colleges.
- The functioning and conduct of the academic activities are in tune with Academic Calendar of the college.
- Proceedings and functioning of all the mandatory bodies are compliant with the guidelines and documentation for the same has been maintained.
- 4. It is observed that the I.Q.A.C. of the college is playing an active role in maintaining quality standards in Teaching- Learning process and functional enough to conduct various curricular, co-curricular and extracurricular activities in college.
- It is observed that the college has been maintaining high academic standards in curriculum design, teaching, assessment strategies and research.
- College encompasses a well maintained lush green campus ensuring adequate availability and optimal utilization of physical infrastructure for teaching learning activities.
